

## Duplicate Papers

The issue of breeding papers is an important task, which was transferred to the Hannoveraner Verband e.V. by the state by the Chamber of Agriculture of Lower Saxony and is controlled by this. A duplicate of the passport / certification of ownership can only be issued to the person who lost the original or last held it in his hands. The following documents are required for issuing duplicates:

- Legally certified statutory declaration of the applicant about the loss of the original paper signed by notary in original
- Exact description of the colour and markings of the horse with identification number (neck or hip brand). This information has to be given by a veterinary and has to be confirmed in a diagram (signalement grafique) and sent to us in original.
- Some mane hair samples with roots to make a parentage verification.

### Finally the following remark:

Please notice that just the person who lost the original is allowed to receive a duplicate!

If the paper has been lost in mail, we need also a Supplement from the person that they never received the passport from the horse.

The decision whether or not duplicate papers can be issued can only be made after receiving the necessary documents.

According to the EU regulation, we are obliged to mark your horse as a non-slaughter horse by issuing a copy. As a result, the horse may no longer be used for human consumption.

Fee for duplicate papers: € 200.00 If the documents are here and okay, we will send the invoice and after payment the passport.

Please note that all the issued duplicate papers incl. life number pedigree and applicant are published in our magazine "Der Hannoveraner"!
